

AUTHORIZATION AND RELEASE – IMAGE

TO: **Producer**

FROM: Production Participant ("I")

The undersigned (also "I") hereby agrees that in consideration of one Canadian dollar (\$1.00) and other good and valuable consideration, including the acting experience the undersigned shall acquire in connection with the Productions (as defined below), the receipt and sufficiency of which is hereby acknowledged, the Producer, its parents, affiliates, subsidiaries, licensees, successors and assigns, shall be entitled to portray, reproduce, photograph and/or otherwise use my image, face, name, voice and sounds, including the performance of any musical compositions, film footage, interview, photograph or other means whatsoever (the "**Appearance**") as being myself or another real or fictional person and to photograph, record and depict the Appearance, accurately or otherwise, with respect to the short film currently entitled _____ and with respect to a "making of" documentary in connection with the filmmaker's competition currently entitled the "**Productions**" with no further obligation to the undersigned. The Producer, its parents, affiliates, subsidiaries, licensees, successors and assigns, shall be entitled to exhibit, broadcast, perform, transmit, reproduce and exploit the Productions, with or without scenes containing the Appearance, in perpetuity, in all manner and media worldwide and in all advertising, publicity, promotion and marketing for the Productions, throughout the universe or, at the sole option, Producer may refrain from exercising all or any of the rights and license herein granted, at any time from time to time, all without liability of any kind to the undersigned.

The undersigned further agrees that Producer may use and license others to use my name, voice, likeness and any biographical material concerning me which I may provide, in any and all media and in the promotion, advertising, sale, publicizing and exploitation of the Productions and/or otherwise and in connection with the Productions, throughout the world in all media, an unlimited number of times in perpetuity. The undersigned further represents that the Appearance will not violate or infringe upon the rights of any third party.

The undersigned hereby waives any right of inspection or approval of the Appearance or the uses to which such Appearance may be put, and I acknowledge that the Producer will rely on this permission, potentially at substantial cost to Producer, and I hereby agree not to assert any claim of any nature whatsoever against anyone relating to the exercise of the permissions granted hereunder. The undersigned hereby waives any and all so-called "moral rights of authors" or similar principles of law which the undersigned may now or later have in the Appearance.

All photographs, film, videotapes and recordings made by the Producer including a depiction of the Appearance and all worldwide copyrights therein, shall be the sole and exclusive property of the Producer, free of all claims by the undersigned or any other party.

The undersigned hereby agrees that the undersigned will not represent that any actor, character or any other person associated with the Productions, appearing in the Productions or in any photographs or sound recordings, represents the undersigned.

The undersigned agrees that the sole remedy of the undersigned shall be, if any, an action at law for damages, if any. In no event shall the undersigned nor any party claiming through or in place of the undersigned, have the right to enjoin the development, production, distribution or exploitation of the Productions which may include photographs or sound recordings of the Appearance.

Producer's rights with respect to the Appearance may be freely assigned and licensed to any person, firm, partnership or corporation. The provisions hereof shall ensure to the benefit of Producer and its successors and assigns and shall be binding upon the undersigned and his/her executors, heirs, administrators and personal representatives. The law of the Province of British Columbia shall govern the terms of this Authorization and Release.

If the undersigned is under 18 year of age Schedule "A" – Parental Consent is incorporated herein by reference.
